#### **EDITORIAL POLICY**

*Nanotechnology Perceptions* is published to provide a stimulating forum for the exchange of ideas and information concerning nanotechnology (including bionanotechnology and nanomedicine), ultraprecision engineering and other emerging technologies. Each issue contains essays on critical issues of the technologies themselves, as well as incisive appraisals of their impact on human life, society and its institutions. Articles are intended for a worldwide readership, and should be of especial interest to leaders in industry, commerce (including bankers and investors), the professions, politics and public administration, and all others who must make decisions based on a sober, impartial assessment of the potential—and risks—of emerging technologies in their areas of work.

Acceptance of a paper will be determined by its quality and interest. Clarity of exposition and broad appeal are important criteria for acceptance. All contributions will be assessed by one or more independent referees, and where necessary an adjudicator.

As well as regular papers (essays), Book Reviews and Letters to the Editor are also published. Letters typically deal with matters arising from essays published in a previous issue, or with any topical issue in nanotechnology requiring brief and incisive comment. Essays are complemented by “Science Briefings”—succinct, intelligible accounts explaining key knowledge—and carefully selected research articles (for the nonspecialist reader, these serve to give a flavour of current cutting-edge developments that may later turn up in devices in daily use).

#### **SUBMISSIONS**

Manuscripts submitted for publication should be sent to the Editor-in-Chief, c/o Collegium Basilea, Hochstrasse 51, CH-4053 Basel, Switzerland. Electronic submissions (preferably LaTeX, Word or PDF files with figures separately as JPEG or TIFF files, saved at a resolution of 600 dpi, CMYK colour) should be sent to [info@colbas.org](mailto:info@colbas.org) with the subject “submit NtP [first author’s name]”, unless otherwise agreed with a member of the Editorial Board (see front inside cover).

Submission of a paper is taken to imply that it is unpublished and is not being considered for publication elsewhere. Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgments are included in their manuscript.

#### **MANUSCRIPT PREPARATION**

A general impression of the required style can be obtained by consulting any recent issue.

It is expected that most papers will be published in English; however papers in French, German and Italian are also acceptable (in which case a summary in English should be provided). A summary (abstract) in English is required for research articles. Otherwise, provision of an abstract is optional, at the author’s discretion (recommended for more technical papers).

References to other published work should be restricted to the most essential and important articles. References should be treated as footnotes. Technical terms should be explained in footnotes. They should be numbered in sequence, the numbers superscripted and placed after any punctuation marks. All footnotes will be placed at the foot of the page on which they are referred to.

#### **PAGE PROOFS, REPRINTS, COPYRIGHT**

Proofs are normally sent in PDF via e-mail. Authors are requested to ensure that they are reachable by e-mail or, if not, to contact the Editorial Office so that alternative arrangements for delivering the proofs can be made. Authors are liable for the cost of significant alterations to their proofs.

Authors receive a subscription for one year to *Nanotechnology Perceptions* (including the issue in which their contribution appears), and a PDF file of their published article if they submitted the manuscript by e-mail. An order form for printed reprints is provided with the proofs; orders must be for multiples of 50 and should be returned with the proofs.

Copyright in any paper accepted for publication is implicitly assigned to the Publisher upon submission. Authors reserve the right to use their articles (subject only to normal acknowledgments to *Nanotechnology Perceptions*) for internal purposes of their institution. They may use the material for presentations or derivative publications, and are free to post their articles on their own or their institution’s websites, preferably with a link to the *Nanotechnology Perceptions* website ([www.nano-ntp.com](http://www.nano-ntp.com)).
